**RENTAL AGREEMENT  
RESERVATION AGREEMENT**

1. Fee is non-refundable and will reserve the space and time.
2. Rentor is responsible for overseeing clean up after the function. Any costs incurred by Hempfield recCenter for clean up, or repair of damages occurring during your function will be billed to the rentor. Signing of this agreement indicates the rentor's acknowledgment of full financial responsibility for damages occurring during the rental period.
3. NO ALCOHOLIC BEVERAGES, drugs or smoking are permitted.
4. No person shall discharge firearms, fireworks with the parks.
5. Disorderly conduct including any violent, abusive, loud boisterous, vulgar, lewd, obscene, indecent or immoral act is prohibited.
6. Vehicles are restricted to roadways. No person shall park or operate any vehicle on the grass or any other non-parking area.
7. No person shall injure deface, remove, cut, or damage any trees, plants, turf, buildings, structures, equipment, supplies or other property.
8. No person shall build a fire except within the grills or receptacles designated for such purpose.
9. No person shall use or possess any bow and arrow, sling shot, or air rifle with the park.
10. Peddling or solicitation is prohibited.
11. Lake Grubb Nature Park: No animals or pets, swimming, wading, boating, ice fishing, ice skating, campfires, overnight fishing, camping, snowmobiles, ATV's, minibikes, Go-carts, horseback riding, or motorcycles.
12. Parks and facilities are open to the public on a first come, first serve basis. Permit and payment of the rental fees grants your group the right to reserve the use of the specified pavilion and to share the other facilities with the public.
13. Please do not overload the outlets at the pavilion to avoid them from tripping the breaker. In the event a breaker is tripped, please call the non-emergency number below. **NO** guarantee the outlets will be reset by the end of the rental
14. Park Hours- Dawn to Dusk
